GAI will repair or replace, at GAI's option, any failure of the covered products during the warranty period at no cost to the Eligible Purchaser, except as specified below.

Eligible Purchaser: This warranty is limited to the original purchaser in MEXICO, CENTRALAMERICA, SOUTHAMERICA and CARIBBEAN of a covered product for use on MEXICO, CENTRAL AMERICA, SOUTH AMERICA and CARIBBEAN. This warranty is not transferable or available to any subsequent purchaser of a Covered Product.

Covered Product: This warranty covers products manufactured by Graphtec Corporation and its affiliated manufacturers, and distributed by GAI, which are purchased by an eligible purchaser from an Authorized Graphtec Distributor (DGA) for commercial use in MEXICO, CENTRAL AMERICA, SOUTH AMERICA & CARIBBEAN.

Warranty Period: This warranty begins on the invoice date as a result of the original purchaser's purchase from a DGA in MEXICO, CENTRALAMERICA, SOUTH-AMERICA and CARIBBEAN. The standard warranty will be 1 year for the CE7000/FC9000/ roller cutting plotters, F-MARK2 and for the FCX4000/FCX2000 flat beds. In the case of registering within the first 3 months of your purchase, the warranty will be extended to 3 years in the CE7000/FC9000 roller plotters, 2 years in the FCX4000 and FCX2000 flatbeds and 1 year on the F-MARK. The warranty for other GRAPHTEC products other than those listed above ends on the 1st anniversary of the date of purchase.
